Meeting Notice posted September 19, 2024

The Board of Education of Dixon County School District 1 (also known as Ponca Public Schools) held a special meeting on Thursday, September 26, 2024 in the Ponca Public Schools library. The meeting was convened in open and public session and advance notice was publicly posted on the school doors, at the post office, the Dixon County Courthouse, the Bank of Dixon County and given to all members of the Board of Education.
